Dear Employer:

This letter is to inform you of the wage and fringe benefit rate allocation per the Collective Bargaining Agreement negotiated by the Chicago Regional Council of Carpenters in full force and effect from June 1, 2019 through May 31, 2022. The following schedules summarize the negotiated increases for June 1, 2020 through May 31, 2021 for the following Illinois county of DeKalb and the portion of Ogle County defined by the following boundaries: IL Route 72, Meridian Road and the Southern Ogle County line; and the portion of Lee County defined as east of Brooklyn Road.

***Working Assessment is four percent (4%) of gross wages.***

The following are the negotiated increases through May 31, 2022:

- Effective June 1, 2021 – an increase of \$2.30 per hour – allocation by union

**COMMERCIAL (CONSTRUCTION DIVISION)**

Covering the Illinois county of DeKalb and the portion of Ogle County defined by the following boundaries: IL Route 72, Meridian Road and the Southern Ogle County line; and the portion of Lee County defined as east of Brooklyn Road.

**Apprentices**

The minimum wage for Apprentices shall be the following percentages of the rate paid to journeymen:
