Dear Employer:

This letter is to inform you of the wage and fringe benefit rate allocation per the Collective Bargaining Agreement negotiated by the Mid-America Carpenters Regional Council in full force and effect from June 1, 2022 through May 31, 2027. The following schedules summarize the negotiated increases for June 1, 2023 through May 31, 2024 for the following Illinois county of DeKalb and the portion of Ogle County defined by the following boundaries: IL Route 72, Meridian Road and the Southern Ogle County line; and the portion of Lee County defined as east of Brooklyn Road.

**Apprentices**

The minimum wage for Apprentices shall be the following percentages of the rate paid to journeymen:

**Wage Deductions:**

***Working Assessment is four percent (4%) of gross wages.***

The following are the negotiated increases through May 31, 2027:

- Effective June 1, 2024 – an increase of \$3.15 per hour – allocation by union.
- Effective June 1, 2024 – 3<sup>rd</sup> and 4<sup>th</sup> Year Apprentices - Carpenters Pension Fund of Illinois, \$.50 per hour increase, MACRC Supplemental Retirement Fund, \$.50 per hour increase
- Effective June 1, 2025 – an increase of \$3.25 per hour – allocation by union.
- Effective June 1, 2025 – 3<sup>rd</sup> and 4<sup>th</sup> Year Apprentices - Carpenters Pension Fund of Illinois, \$.50 per hour increase, MACRC Supplemental Retirement Fund, \$.50 per hour increase
- Effective June 1, 2026 – an increase of \$3.35 per hour – allocation by union.
- Effective June 1, 2026 – 3<sup>rd</sup> and 4<sup>th</sup> Year Apprentices - Carpenters Pension Fund of Illinois, \$.50 per hour increase, MACRC Supplemental Retirement Fund, \$.50 per hour increase

It is important that all Employers make the rates reported in this document payable on June 1, 2023. Thank you for your cooperation.
