## Working Assessment is four percent (4%) of gross wages.

The following are the negotiated increases through May 31, 2027:

- Effective June 1, 2025 an increase of \$3.25 per hour allocation by union.
- Effective June 1, 2025 3<sup>rd</sup> and 4<sup>th</sup> Year Apprentices Carpenters Pension Fund of Illinois, \$.50 per hour increase, MACRC Supplemental Retirement Fund, \$.50 per hour increase
- Effective June 1, 2026 an increase of \$3.35 per hour allocation by union.
- Effective June 1, 2026 3<sup>rd</sup> and 4<sup>th</sup> Year Apprentices Carpenters Pension Fund of Illinois, \$.50 per hour increase, MACRC Supplemental Retirement Fund, \$.50 per hour increase
